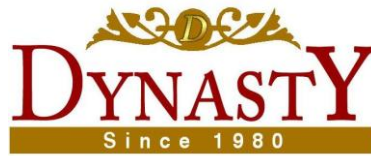

**Dynasty Wins Bronze Award in the  
“2011 Cathay Pacific Hong Kong International Wine & Spirit Competition”**

(Hong Kong, 5 December 2011) – Dynasty Fine Wines Group Limited (“Dynasty” or the “Group”) (Stock Code: 828), a premier winemaker in China, is pleased to announce that Dynasty Premier Royal Selection Cabernet Sauvignon Reserve 2005 has garnered the bronze award under the tasting category “Cabernet Sauvignon 2005” in the “2011 Cathay Pacific Hong Kong International Wine and Spirit Competition” (HKIWSC). This event is the largest pan-Asian wine and spirit competition of its kind, with a total of 1,655 entries coming from 48 countries or regions.

Dynasty Premier Royal Selection Cabernet Sauvignon Reserve 2005 is a dry red wine made from the ripest Cabernet Sauvignon grapes with raspberries, black cherries and blackcurrant notes and is aged in French and Spanish oak barrels.

The HKIWSC operates according to the highest global standards in judging, product storage and result integrity. The competition was chaired by Ms Debra Meiburg MW, one of Asia’s first Masters of Wine, and the guest VIP judge, Mr Alberto Antonini. Judging was undertaken by teams with some of the most distinctive palates in Asia from Hong Kong, India, Mainland China, Macau, Taiwan, Singapore, Malaysia, South Korea and Thailand. They were specially flown in for the event.

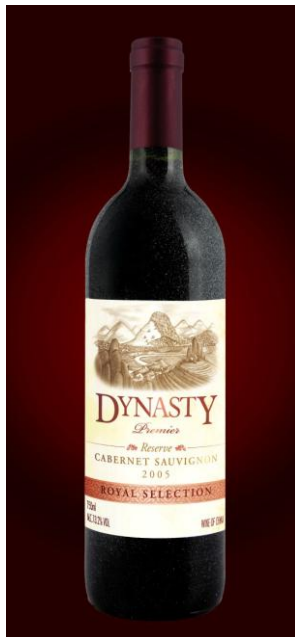
